Format the resolution by putting the date and resolution number at the top. If it's the boards first resolution, you can number it whatever you want. Consider using something like 0001 and then giving all future resolutions a consecutive number. Form a title of the resolution that speaks to the issue that you want to document.

These resolutions are passed by the board, officially recorded by a corporate secretary and filed among a company's official records. The corporate resolution for signing authority is a specific corporate resolution that authorizes specific corporate officers with the legal standing to sign contracts on behalf of the corporation.

Draft the resolution. Board resolutions typically follow a general format, which begins with the statute or bylaw that provides the board with the authority to create the resolution and then goes into the details of the resolution. Several examples can be found online.
