Political opinion; If you are eligible for asylum you may be permitted to remain in the United States. To apply for asylum, file a Form I-589, Application for Asylum and for Withholding of Removal, within one year of your arrival to the United States. There is no fee to apply for asylum.

People who are eligible for political asylum are exempted from several grounds of inadmissibility that would cause other immigrants to be deported or not allowed to enter in the first place. Immigration violations such as entering illegally or living and working in the United States illegally do not prevent someone from being granted asylum.

Asylum Application: USA Law, Qualification & Requirements

The United States recognizes the right of asylum for individuals as specified by international and federal law. A specified number of legally defined refugees who either apply for asylum from inside the U.S. or apply for refugee status from outside the U.S., are admitted annually. Refugees compose about one-tenth of the total annual immigration to the United States, though some large refugee ...

An asylee—or a person granted asylum—is protected from being returned to his or her home country, is authorized to work in the United States, may apply for a Social Security card, may request permission to travel overseas, and can petition to bring family members to the United States.

There is no limit to the number of people who can receive political asylum in the United States. Anyone who fits the requirements can live and work in the United States for life, along with his or her spouse and young, unmarried children. After one year of being in asylee status, an asylee can apply for a Green Card and, eventually, citizenship.

Political Asylum USA: Asylum Immigration Status in United ...

An asylee is a person who meets the definition of refugee and is already present in the United States or is seeking admission at a port of entry. Refugees are required to apply for Lawful Permanent Resident (“green card”) status one year after being admitted, and asylees may apply for green card status one year after their grant of asylum.
