The VAT or IMESI registration procedure in Uruguay is the same as for the rest of the local taxes (corporate income tax, capital tax, etc). In order to develop a commercial activity in Uruguay, a foreign company must register for all tax purposes (and not just for VAT), as it would need to set up a permanent establishment.

Uruguayan Tax System has been modified by Law 18.083 which came into force on July, 1st 2007. Taxation is mainly regulated by the National Tax Code of 1996 and the decrees that regulate the Code. Uruguay has adopted a territorial concept of taxation.

Uruguay has Double Tax Treaties in force and effect with Argentina, Belgium, Chile, Ecuador, Finland, Germany, Hungary, India, Liechtenstein, Luxembourg, Malta, Mexico, Portugal, Rumania, Singapore, Republic of Korea, Spain, Switzerland, United Arab Emirates, United Kingdom of Great Britain and Northern Ireland, and Viet Nam (treaties with several other countries/territories are in the process of negotiation but have not been internalized yet and are still not in force).
